Contractual riders

Riders regarding the seller

- a) The seller is obliged to deliver the goods at the destination in due time of 14 days after receiving the order.
- b) If the goods delivered by the seller prove to be unsuitable, the seller is obliged to replace the goods or to compensate the buyer. Any of the buyer's complaint will be laid down in due time of 10 days from receiving the goods.
- c) If Slovak natural person or corporate body will use the goods in non-commercial purpose will be hold answerably judicial way.
- d) The buyer without the seller's approval can not modify the contractual conditions.
- e) If the invoice is not paid off at time, the seller will send a warning note. If the payment is not made in due time of 7 days after receiving the note, the company will levy penalties of 5% per month.

Riders regarding the buyer

The buyer is obliged to pay the requested price by the seller as well as all the taxes that come with the delivery of the goods. The payment will be made through bank operations in the seller's company bank account, if not mentioned otherwise.

The buyer is obliged to pay the price established at the date of the delivery of the order. The delivery date of the goods is 14 days. If the buyer will use the goods in commercial purposes, he will be judged by the qualified instance of the address country.
